

NOTICE OF FORECLOSURE SALE

Effective as of February 5, 2021, Charles N. Choate and Alma Potts (“Grantor”), executed a Deed of Trust (the “Deed of Trust”), conveying to Charles W. Downing, as Trustee, the Real Property (as hereinafter defined), said Deed of Trust originally filed for record under Document Number 2021008514, in the Official Public Records of Uvalde County, Texas, to secure Patricia D. Casey and Orvel G. Casey (“Lender”), in the payment of a promissory note of even date, in the original principal sum of \$260,000.00, executed by Grantor, payable to Lender (the “Note”), together with all other debt that Grantor may owe Lender.

The Real Property is hereinafter referred to as the “Collateral.”

Lender has advised Trustee that: (i) default has occurred in the payment of the Note and in the performance of the obligations of the Deed of Trust; (ii) the Note is now wholly due; and (iii) the Note remains unpaid.

Lender, as the owner and holder of the Note, has instructed Trustee to sell the Collateral, Lender having elected to proceed against and sell the Collateral in accordance with Lender’s rights and remedies under the Deed of Trust.

NOTICE IS HEREBY GIVEN that on Tuesday, April 2, 2024, at 1:00 p.m., or not later than three hours after that time, I will, as Trustee under the Deed of Trust, begin the sale of the Collateral, at public auction, to the highest bidder for cash, except that Lender’s bid may be by credit against the Note, at the area designated by the Commissioners’ Court of Uvalde County, Texas for conducting foreclosure sales, being the steps on the east side of the Courthouse situated at 100 N. Getty Street, Uvalde, Texas 78801.

The Real Property is described as follows:

14.097 acres out of the Carlos Huizar Survey No. 72, Abstract No. 241, Uvalde County, Texas, and being all of that 13.061 acre tract conveyed to O. Glenn Casey et ux by deed recorded in Document No. 2006001266, Official Public Records, and a part of that 3.000 acre tract conveyed to O. Glenn Casey by deed recorded in Document No. 2006004272, Official Public Records, Uvalde County, Texas, said 14.097 acres being more particularly described by metes and bounds s described in Exhibit “A” to Warranty Deed with Vendor’s Lien recorded under Document Number 2021008513 in the Official Public Records of Uvalde County, Texas.

The Collateral will be sold subject to any prior liens, outstanding ad valorem taxes, other matters of record in Uvalde County, Texas, and by instruments filed with the Texas Secretary of State's office, to the extent such matters are still effective and are superior to the liens and security interests on the Property granted in the Deed of Trust, and other exceptions to conveyance and warranty in the Deed of Trust.

Any real or personal property described in the Deed of Trust not to be sold as part of the Collateral in the sale may be noticed, at Lender’s election, for sale at a subsequent date and time


