We will work closer with Cactus Jack earlier on next year to encourage bullriders and fans to stay in county lodging, look into a meet and greet with bullriders, Leon Coffee, and concert event outside the city limits to promote lodging in the County and bring more people. Possibly coordinate shuttle transportation.

Tejano Music Festival: Discussion about Tejano Music Festival produced by Mark Esparza to be held at the Golf Course of Texas on Oct. 15. Mark Esparza is requesting \$41,000 total to produce the event. The THCRR staff recommended that the Board agree to invest \$10,000 from the Tax account and \$10,000 from Corporate account to share profit with The Golf Club of Texas, assuming they will invest the remaining funds. A motion was made by Tim Hester to approve investment in Tejano Music Fest as recommended. 2nd by Chase Roosa Gabe Gonzalez abstained from voting. Motion passed.

Nominating Committee: The Board discussed the process for nominating committee and election at the upcoming Annual Membership Meeting. Rob Fayle requested we confirm the process and which seats will be up for reelection, and confirm with Garry Merritt about filling a Large Lodge Owner seat.
