#### 1. Call to order, Invocation and Pledge of Allegiance:

# 3. Consider and act upon presentation of Keep Utopia Beautiful and Hill Country Alliance regarding dark skies initiative:

The two organizations are leading an initiative to preserve the dark skies in our region by educating residents about the International Dark Skies recommendations regarding the elimination of light pollution and light trespass. They requested that the court take action to encourage citizens to use proper lighting and best practices that follow up to date guidelines and technology for efficient, cost effective and non-intrusive lighting. Hill Country Alliance Program Manager, Cliff Kaplan, read and presented resolution to the court.
