BE IT REMEMBERED that on the 24th day of September 2018, the Honorable Commissioners Court of Uvalde County, Texas convened in the Commissioners' Courtroom of the Uvalde County Courthouse. The following members were in attendance:

1. Consider and act upon call to order, invocation and pledge of allegiance:

The Honorable William R. Mitchell called the meeting of September 24th, 2018 to order at 10:00 A.M., followed with the invocation, led the Pledge of Allegiance, and Texas Pledge Of Allegiance.

2. Consider and act upon approval of minutes:

Motion by Commissioner Bates to approve minutes of September 2nd, 2018 and September 10th, 2018.

Seconded by Commissioner Pargas. The motion unanimously carried (4-0).

3. Consider and act upon adoption of 2018-2019 Uvalde County General Fund Tax Rate:

Outlined by County Auditor, Alice Chapman.

Motion by Commissioner Bates that the property tax rate be increased by the adoption of a tax rate of .5257 for general fund and .090 for debt service fund, which is effectively a 2.38 per cent increase.

Seconded by Commissioner Pargas.

4. Consider and act upon adoption 2018-2019 Farm Market Road/Flood Tax Rate: Outlined by County Auditor, Alice Chapman.

Motion by Commissioner Bates that the property tax rate

15. Consider and act upon approval of monthly reports:


