

## **MINUTES**

BE IT REMEMBERED that on the 13<sup>th</sup> day of January, 2020, the Honorable Commissioners Court of Uvalde County, Texas convened in the Commissioners Courtroom of the Uvalde County Courthouse. The following members were in attendance:

### 1. Consider and act upon call to order, invocation and pledge of allegiance:

The Honorable William R. Mitchell called the meeting of January 13, 2020 to order at 10 AM followed with the invocation, led the Pledge of Allegiance to the United States flag and Texas Pledge of Allegiance.

### 2. Consider and act upon approval of minutes:

Motion by Commissioner Bates to approve the minutes of December 9, 2019. Seconded by Commissioner Garza. Motion carried (2-0).

## 3. Consider and act upon Uvalde Memorial Hospital construction update by Administrator Tom Nordwick:

Uvalde Memorial Hospital Administrator Tom Nordwick provided the Court with a construction update of the new \$91 million dollar state of the art facility along with a Uvalde Memorial Hospital Community Impact 2019 Year in Review including financials, charity care, community partnerships and regional cancer services.

## 4. Consider and act upon approving surveying contracts awarded per Texas Community Block Grants 7218145 and 7218155:

County Consultant Carl Esser requested approval from the Court for two engineering service contracts with D.G. Smyth & Company for surveying in conjunction with the Texas Community Development Block Grants #7218145 (First Time Sewer Service) and #7518155 (First Time Water Service) for the Flores Street, Uvalde, Texas, Colonia Construction. The Court had previously awarded the engineering service contracts to D.G. Smyth & Company, Inc. on November 12, 2019. A separate vote was recorded for each contract.

### 5. Consider and act upon accepting grant award from USFWS per CR 348 at Bear Creek:

County Consultant Carl Esser outlined the award of the U.S. Fish and Wildlife Service CFDA Program Grant in the amount of \$125,000. The funds under this award are to be used to help replace the current low water crossing on County Road 348 over Bear Creek with a goal to replace the existing culverts with a fish friendly flow through structure. The construction project will be managed by the Uvalde County Road Department with a required grant completion date of five years.

Motion by Commissioner Bates to approve U.S. Fish and Wildlife Service Grant award. Seconded by Commissioner Garza.

Motion carried (2-0).

### 6. Consider and act upon resolution per Stonegarden Grant:

County Consultant Carl Esser requested consideration and approval on Resolution 2020-1 in support of the Uvalde County application for the Homeland Security Grant Program for the Uvalde County Operation Stonegarden FY 19 in the amount of \$217,125. This is a twelve month grant with a start date of March 1, 2020 through February 28, 2021 to assist the Uvalde County Sheriff with overtime pay for enhanced patrol, night vision equipment, car radios, hand held radios and any equipment used for border operations. No County match is required. Motion by Commissioner Garza to approve resolution.

Seconded by Commissioner Bates.

# 7. Consider and act upon Joint Primary Election Services Contract with Republican Party:

Elections Administrator Melissa Jones Bradham requested consideration and approval on a Joint Primary Election Services Contract with the Uvalde County Republican Party Chairman James Jeffrey Santleben as authorized by Section 31.092(b) of the Texas Election Code for the purpose of conducting the Uvalde County Joint Primary Election on March 3, 2020 and the Uvalde County Joint Runoff Election, if necessary, on May 26, 2020.

Motion by Commissioner Bates to approve Joint Primary Election Services Contract with the Republican Party.

# 8. Consider and act upon Joint Primary Election Services Contract with Democratic Party:

Elections Administrator Melissa Jones Bradham requested consideration and approval on a Joint Primary Election Services Contract with the Uvalde County Democratic Party Chairman Carlos Lopez as authorized by Section 31.092(b) of the Texas Election Code for the purpose of conducting the Uvalde County Joint Primary Election on March 3, 2020 and the Uvalde County Joint Runoff Election, if necessary, on May 26, 2020.

Motion by Commissioner Garza to approve Joint Primary Election Services Contract with the Democratic Party.

# 9. Consider and act upon contract between Department of Informational Services and Uvalde County related to the use of DIR shared services:

Elections Administrator Melissa Jones Bradham requested consideration and approval of a contract between the Department of Informational Services and Uvalde County to conduct a cyber security elections assessment for the purpose of providing aggregate data to the Secretary of State Elections Division.

### 10. Consider and act upon donation from Stephen Rambie for use at Nutrition Center:

The Court considered and officially accepted a \$500 donation from local resident Stephen Rambie to be used at the Uvalde County Nutrition Center.

### 11. Consider and act upon Road Administrators report:

Road Administrator Dee Kirkpatrick informed the Court that the Uvalde County Road Department worked on installing two cattle guards on County Road 335, Mulching on County Roads 102, 349 and 413. Cutting brush and grass on County Road 312 A. Currently waiting on permits from the Texas Parks &Wildlife and U.S. Army Corp. of Engineers to remove gravel from river to repair County Road 416 crossing.

County Auditor Alice Chapman outlined line item budget amendments presented to the Court for consideration and approval to close out fiscal year 2019.
