1. Consider and act upon call to order, invocation and pledge of allegiance:

The Honorable William R. Mitchell called the meeting of February 10, 2020 to order at 10 AM followed with the invocation, led the Pledge of Allegiance to the United States flag and Texas Pledge of Allegiance.

2. Consider and act upon approval of minutes:

Motion by Commissioner Bates to approve the minutes of January 27, 2020.
Seconded by Commissioner Garza.
Motion carried (3-0).

3. Consider and act upon racial profiling report filed by County Constables:

Texas Code of Criminal Procedure §2.132 requires the chief administrator of an agency, regardless of whether the administrator is elected, employed or appointed to submit an annual report of the information collected relating to motor vehicle stops in which a ticket, warning or arrest is made as a result of those stops, including information relating to the race or ethnicity of the individual detained. The Court reviewed and approved reports submitted by Constable Pct. 1 Johnny J. Field; Constable Pct. 2 Weldon McCutchen; Constable Pct. 4 David Valdez; and Constable Pct. 6 Robert A. Moss.

Motion by Commissioner Pargas to approve racial profiling reports submitted by Constables.
Seconded by Commissioner Bates.
Motion carried (3-0).

4. Consider and act upon racial profiling report by County Sheriff:

Chief Deputy Sheriff Doug Postert outlined the racial profiling review for the Uvalde County Sheriff's Office for the period of January 1, 2019 through December 31, 2019 as required annually by the Texas Code of Criminal Procedure Article 2.132, Article 2.133, Article 2.134 and Article 2.135 regarding racial profiling discrimination.

Motion by Commissioner Pargas to approve racial profiling report submitted by the Uvalde County Sheriff's Office.

Seconded by Commissioner Garza.

Motion carried (3-0).

5. Consider and act upon resolution to apply for metal detector funding:

This agenda item was tabled.

6. Consider and act upon order to permit sale of fireworks for Texas Independent Day:

Occupations Code §2154.202(h) permits the Commissioners Court to adopt an order authorizing the sale of fireworks for Texas Independence Day on March 2, 2020. If the court decides to permit the sale of fireworks during the Texas Independence Day period, the order must be adopted before February 15, 2020.

Motion by Commissioner Garza to approve order authorizing Texas Independence Day Fireworks Sale.

Seconded by Commissioner Bates.

Motion carried (3-0).

7. Consider and act upon contract renewal with Indigent Healthcare Solutions:

Auditor Alice Chapman requested consideration of a contract renewal with Indigent Healthcare Solutions for software case management for the Uvalde County Indigent Health Care Program. The memorandum of understanding is for a period of three years beginning March 1, 2020 until March 1, 2023 at a rate of \$1,059.00 per month.

Motion by Commissioner Pargas to approve contract renewal.

Seconded by Commissioner Garza.

Motion carried (3-0).

8. Consider and act upon Road Administrators report:

Road Administrator Dee Kirkpatrick informed the Court that the road department was trimming and cutting right of ways, patching holes and working on the stock pile built up to begin work on County Road 348.
