1. Consider and act upon call to order, invocation and pledge of allegiance:

The Honorable William R. Mitchell Uvalde County Judge called the meeting of October 25, 2021 to order at 10:00 AM followed with the invocation, led the Pledge of Allegiance to the United States flag and Texas Pledge of Allegiance.

2. Consider and act upon approval of minutes:

Motion by Commissioner Bates to approve the minutes of October 12, 2021.

3. Consider and act upon authorization of Commissioner Jerry W. Bates to preside over Uvalde County Commissioners Court meetings and execute documents approved by the Commissioners Court during official court setting during the absence of the Uvalde County Judge:

The Court considered authorizing Jerry W. Bates, Commissioner Pct. 3 to preside over Commissioners Court meetings and execute documents officially approved by the Court in the absence of William R. Mitchell Uvalde County Judge.

Motion by Commissioner Yeackle to authorize Jerry W. Bates Commissioner Pct. 3 to preside over Commissioners Court meetings and execute documents officially approved by the Court in the absence of William R. Mitchell Uvalde County Judge.

4. Consider and act upon RFP Proposal on Jail Commissary License Agreement for the Sheriff's Office:

This agenda item was not considered by the Court due to a conflict with the advertising date. No action taken.

5. Consider and act upon preliminary hearing on subdivision plat consideration for Hill Country Houses, LLC:

Preliminary approval was considered by the Court for the Crusher Heights Subdivision owned by Hill Country Houses, LLC located at 4379 County Road 301 in Knippa, Uvalde County, Texas.

Motion by Commissioner Bates to authorize preliminary approval to the Crusher Heights Subdivision.

6. Consider and act upon HTS managed services contract for the CSCD department:

The Court considered an annual Buy Board Contract #574-18 by and between the County of Uvalde and HTS Voice & Data Systems to provide managed computer related services to the 38th Judicial District Adult Probation & CSCD in Uvalde/Real County. The term of this agreement is for a period of one year at a cost of \$13,305.60 to be paid monthly in the amount of \$1,108.80 to begin on October 1, 2021.

Motion by Commissioner Yeackle to approve the HTS managed services contract for the Adult Probation & CSCD department.

Seconded by Commissioner Garza.

Motion carried (4-0).

7. Consider and act upon Road Administrators Report:

Road Administrator Dee Kirkpatrick informed the Court that the Road Department patched roads, mowed right of ways, added caliche to Fairplex trailer parking lot and milled; County Road 204, 371 and North Camp, replaced culverts on County Road 371 and Marsh Lane and installed speed bumps at Uvalde Estates.
